Statement 2/2021 from "Pyidaungsu Hluttaw Representatives"

5th February, 2021

- 1. We, Pyidaungsu Hluttaw Representatives, are democratically elected from 2020 General Election held on 8th November, 2020.
- 2. It is already known that although it was announced that Hluttaw meetings would be held on 1st February, 2021, the Commander in Chief unlawfully seized national power and thus, Hluttaw meetings were not held on the announced date.
- 3. We, however, took parliamentary oaths in Nay Pyi Taw Guest House (2) on 4th February, 2021 and then, in accordance with 2008 constitution we are responsible for legislature, as well as for organizing and approving a committee for the selection of "President".
- 4. We, elected MPs, announce that any organizations, ministries and government committees formed by the Military Government are not recognized and illegally accredited.
- 5. We, elected MPs, inform United Nations and the international communities that only the government organization led by President U Win Myint is legitimate.
- Commander-in-Chief's seizing power against the 2008 constitution has no legitimate influence over our constitutionally irremovable power granted by the people in Myanmar.
- 7. Therefore, it has also no legitimate power to remove off our constitutional duties and responsibilities as Pyidaungsu Hluttaw MPs.
- 8. Committee representing Pyidaungsu Hluttaw CRPH has been formed together with the following MPs in order to shoulder a MP's responsibilities granted by the citizens, to attempt for the unconditional release of President U Win Myint, State Counselor Aung San Su Kyii and other detainees, and to implement normal operations of Pyidaungsu Hluttaw.

We announce that this CRPH committee will attempt for implementing the requests from Pyidaungsu Hluttaw Representatives' Statement announced No 1/2021, announced on 3rd February 2021, and will act as a committee taking responsibility for Pyidaungsu Hluttaw for cooperations with UN and international communities.
